

in5 Venue Booking Terms and Conditions

The Licensor (in5) and the Licensee (Venue Booking Party) accepts to a license the Designated Space for the Booking Period subject to the below terms:

GENERAL TERMS

in5 Venues availability can be checked dynamically and paid online.

For special booking requirements, send an email at calendar@in5.ae.

in5 Venues can be booked for corporate events. Social Events like Weddings, Birthday/Social Entertainment Parties are not permitted at in5 venues. The booking will be instantly cancelled in case of non-compliance to purpose of the booking.

No political and religious activities are held in the Designated Space.

The venue booking period includes any pre/post setup related time.

Subject to availability of the venue, additional charges are applicable prorated, if the venues are used over the booking period.

No alcoholic beverages are allowed into the Designated Space.

The Licensee can use F&B services from any service provided who is permitted to do takeaway/outdoor catering.

No pets are allowed in the Designated Space;

BOOKING CHANGE AND CANCELLATION POLICY

Unless agreed otherwise in the event of booking cancellation, the Licensee must notify the Licensor in writing. The cancellation fee shall apply in accordance with the following:

- a) Cancellation done thirty (30) days or more prior to the start date 50% of total fee will be deductible.
- b) Cancellation done between twenty-nine (29) days to eight (8) days prior to the start date 75% of total fee will be deductible.
- c) Cancellation done seven (7) days or less prior to the start date 100% of total fee will be deductible.

PERMISSIONS

For any shooting related bookings, permission issued by [Dubai](#) Film and TV Commission is mandatory and must be obtained by the Licensee and submitted to Licensor team prior to the start of the Booking Period. The shooting cost for up to 8-Hours is AED 10K.

For ticketed event bookings, permission from [Department of Economy and Tourism](#) is mandatory and must be obtained by the Licensee and submitted to Licensor team prior to the start of the Booking Period.

For food trucks, various permissions are mandatory, this includes and not limited to the Dubai Economic Department and or Dubai Development Authority (trade license and name), Dubai Municipality (food safety and health permits), Roads and Transport Authority (setting up shop in public places).

SECURITY DEPOSIT

Where required in the Booking, the Licensee shall pay the Security Deposit to the Licensor upon making the Booking. The Licensor can have recourse to such Security Deposit at any time for securing performance and/or to partly compensate for any liabilities, losses, damages, expenses, penalty fees, and/or costs arising out of the breach of obligations by, or negligence, omission, misconduct and/or bad faith of the Licensee, without prejudice to the rights and remedies of the Licensor under this Agreement or under applicable law. No interest amount will accrue on the Security Deposit.
